A.2. Highlights of main achievements

During the second project period, the following achievements were obtained:

Management - The second project period, the management work package was more focused on coordination of modifications in the project application, organization of the Second Steering Committee Meeting, participation in the trainings organized by MA and JTS on project management (LP, PP2 and PP3). In order to ensure timeliness and quality of implemented project activities, in line with the strategic objectives, goals and scope of the HydroEcoNex, an administrative monitoring visit was carried by LP and PP2 to Ukraine (PP4 and PP5). The progress of key project documents were monitored and recommendations were given for improvement.

Implementation - The partners made an overview of historical and own research data and produced the first draft of the protocol of the impact. In the draft presented in the second project period, it is described the general situation of the major impact caused by hydropower on river ecosystems, including disturbance of the hydrological and hydrochemical regime, impact on hydrobiont community and penetration of invasive species, also the impact on microclimate and economic measures for evaluating the impact. The final protocol will contain recommendations on major parameters to be sampled for assessing the hydropower impact. Project results were presented at the Danube Cooperation Forum and 2nd Dniester river Commission. **Communication -** Project partners continue to work on dissemination of project results via distribution of project materials (leaflets produced by LP, PP4 and PP5, brochures and calendars - produced by PP2) at various events - such as Water's Day, Europe's Day as well as Environment's Day as well as presenting information on social media (Facebook), on TV and printed media. LP continued work toward design and completion of information of the project website.

LP made an overview of literature and multiannual laboratory data was systematized and also new data on hydrochemical, hydrobiological and ichthyological state of lower Dniester was collected. The results are reflected in the protocol of monitoring the impact. PP2 made a comprehensive review of relevant foreign and national publications on monitoring the conditions of aquatic and riparian ecosystems, the methodic and set of indicators, best describing different impacts on transboundary river ecosystems, were proposed. Methodologies for the economic valuation of the water ecosystem services were selected. PP3 made a review of relevant national publications on monitoring the conditions of aquatic and riparian ecosystems, which allowed to propose the set of indicators describing different impacts on transboundary river ecosystems. The following issues were performed: Completion of the database with the historical data in the Romanian part of the Prut River basin on the variation of river flow and impact on river biodiversity. PP4 collected data from expedition carried out on Dniester river and analyzed the literature, presented a retrospective analysis of the 40s and 50s and the modern period from 2006 to identify indicators under the impact of hydropower development and climate change, which are reflected in the protocol of monitoring the impact. PP5 contributed to the completion of electronic database on the values of the parameters of the atmosphere and soil (14 parameters) of the meteorological stations of Dniester River basin; completion of field data of the hydrological regime at the hydrological posts of the Dniester River and its tributaries, calculating the volume of daily runoff at the sampling station Maiaky (Lower Dniester). All partners carried out also expeditions for estimation of the actual state on Dniester and Prut river and identify the main set of indicators of hydropower impact on hydrological, hydrobiological and ichthyologic parameter
